Scholarship Program Guidelines

The Workspace Innovation NCCAR CCIM Scholarship was created to support qualified real estate professionals in their efforts to achieve the CCIM designation. Recipient should exemplify the high caliber of professionals that comprise the CCIM Institute and NCCAR.

Scholarship Selection Criteria

Includes the following:

- Each applicant should be able to demonstrate a commitment to a commercial real estate career (see application).
- Each applicant should be able to demonstrate active involvement as a dues paying member with NCCAR.

Scholarship Value

Recipient will receive a \$500 scholarship to go toward **one** of the following CCIM designation courses: **CI 101, CI 102, CI 103 or CI 104.**

NOTE: Scholarship recipient will be responsible for reimbursing CCIM for remaining amount for class.

Procedure

Applications are submitted directly to NCCAR for selection.

NOTE: The scholarship needs to be used in 2017. The scholarship cannot be applied retroactively to any course already taken; the scholarship is not redeemable for cash; the scholarship will not reimburse individuals for any courses already taken.

Deadline for Submission to NCCAR

APRIL 30, 2017

Recipient Notification

Email notification will be sent on or before MAY 4, 2017 notifying those selected. Winners will receive funds from scholarship once class is registered.
